

CHRISTCHURCH MINI GARAGE PRIVACY POLICY

At Christchurch MINI Garage, your privacy is important to us. Christchurch MINI Garage take great care at all times to deal with all personal information in a compliant and confidential manner and expect all of our employees, contractors, business partners and service providers to comply with the Privacy Act 2020 and treat personal information accordingly.

Privacy Policy: Christchurch MINI Garage recognises its responsibility, and is committed to, ensuring the privacy of your personal information. When you enter personal information into the Website in order to receive or use services the terms of this Privacy Policy will apply to that information.

Collection of Personal Information: You agree that Christchurch MINI Garage may collect information about you including information about your use of the Website and information you enter into the Website. Christchurch MINI Garage will treat all personal information it collects in accordance with this Privacy Policy.

Changes to the Privacy Policy: Christchurch MINI Garage may, from time to time and in its sole discretion, modify, alter or otherwise change this Privacy Policy with or without notice to you. All such changes will be effective immediately upon the updating of the webpage on the site at which the privacy policy is contained. You agree to check the privacy policy and be bound by the privacy policy that is in effect at the time at which you access the site.

Use of the Information: Christchurch MINI Garage will use your personal information: (a) for the purposes you provided it to Christchurch MINI Garage; (b) to send you messages via email, telephone, post, facsimile, SMS or social media to market or promote MINI goods and services, or have supplied your contact details to us by other means for that purpose. You may unsubscribe to marketing communications at any time by following the directions contained within the communication or by contacting our customer care team on the details listed within this privacy policy.

Related Entities: Christchurch MINI Garage may pass your personal information on to BMW New Zealand Limited for the purposes described in the clause above.

If you would like to opt out of marketing communications from any related Christchurch MINI Garage or BMW Group New Zealand Limited you can do so by following the unsubscribe directions in a message they send, or by contacting them directly.

Third Parties: Christchurch MINI Garage will not release your personal information to any third party except where required to, permitted to by law, where you have authorised us to do so or where disclosure is connected to the purpose for which the information was collected.

Cookies and Information Collected: Cookies are small files which are temporarily installed on your hard drive.
